Inaugural Trailblazer 5K a Success

The Amy Biehl Community School's inaugural Trailblazer 5K run held on March 19th was a huge success despite a brutally cold and windy spring morning.

Even though temperatures were low, spirits were high as the Amy Biehl Choir kicked off the event with the National Anthem.

As the wind chill hovered around 10

degrees, runners bundled in layers of clothing, jackets, hats and gloves were dancing around to keep warm prior to the beginning of the race.

Once the race started, word from the racecourse was that the temperatures weren't so bad, but as the first runners crossed the finish line the stinging cold was visible on grimaced faces and bright red legs.

In total, 111 runners participated in the 5k and about 30 children ran the kids 1K, exceeding the Amy Biehl PTC's fundraising goals. Registration fees from the race will go towards supporting classroom projects, field trips and extracurricular activities at the school.

Dave Tolen, known as Coach Dave in the hallways of Amy Biehl, was the lead organizer of the event. "We are really thankful for all of the support we received this year and look forward to building on our success in the years to come," said Tolen.

Plans are already underway for next year's race to be held in spring of 2017. Tolen said he hopes to increase participation and may even consider adding a 10K to the lineup.

La Entrada's Communications Committee helped get the word out about the 5K and looks forward to continued collaboration with Amy Biehl Community School. Staci Stevens will serve as a liaison between the school and community association so we can better support each other's events and work towards enhanced cooperation while building a true sense of community in our neighborhood.

La Entrada Getting Ready for a Busy Spring

The March 17th La Entrada Board Meeting was held at the Rancho Viejo Fire Station.

The meeting was called to order by Cass Thompson, President. Michael Smith, HOA manager, reviewed the finances for our community. He reported that the budget is in good shape.

Judy Keller, Chair of the Design and Review Committee reported that the committee is working diligently to review all of the numerous requests for the new homes being built.

She did express concern about residents not submitting approvals and ignoring the regulations that presently exist. Another concern is that the community needs to "put some teeth" into the violations of the guidelines. Cass Thompson reported that the board members will be meeting with the compliance officer on March 24th to review what steps are necessary to improve the situation. This issue is common for newly developing communities as new homes are added. A report at the next meeting will discuss decisions needed to assure the quality of our community standards.

Pat Barnes reported that the Rancho Viejo/Firewise/USA Day has been scheduled for May 7th.

She also announced that the committee has been working with Amy Biehl Community School to implement a new firewise curriculum designed by Dr. Judy Reinhartz. This project received a \$500 national grant. The project will also be presented at the Firewise/USA conference held in Las Vegas, Nevada in May. La Entrada is leading the way with positive actiivities to involve the youth of our community.

Cass Thompson announced that the mirror requested for a blind alley is in place at the alley behind Calle Aqua Clara



Alina Catanach reported that almost all of the homes have been sold in Phase 1. The construction crews will be building about one house a week for the next few months.

Spring Is Here!

That means it time to cleanup and thanks to Proscape we have some tips to help you spruce up your landscaping and get it ready for the beautiful weather ahead.

- * Clean out turf, planter beds and garden areas, removing dead and fallen branches, leaves and any debris.
- * Trim back your perennials to the base (some exceptions may apply, such as Russian Sage). Lightly prune shrubs and trees.
- * Apply fertilizer and compost, followed by fresh mulch approximately 2-3" in depth. Mulch is excellent for preventing weeds and retaining soil moisture.
- * Spring is the ideal time for new plantings and/or dividing and transplanting existing plants. Be sure to consider sun and shade requirements.
- Turn on your irrigation system once nighttime freezing temperatures have subsided. Make sure to test your system for any leaks or other issues. If needed, replace broken or missing emitters and sprinkler heads and make sure your irrigation controls are set.

And for those of you who would just rather not try that yourself, Proscape Landscape Management will do the job for your for \$70 + tax instead of the standard price of \$110 for all irrigation startups at La Entrada. Large Item Pickup

The date for large item pick up in La Entrada is the third Friday of each month. The next dates of service is Friday, April 15 and May 20, 2016.

Please contact Michael Smith at 954-4479 to be put on the schedule. Provide your address, telephone number and description of item(s). Remember to sign up no later than the Monday prior to the Friday pick up dates.

Items allowed:

- Furniture: Bulky items cannot exceed eight feet in length, four feet in width or weigh more than 150 pounds.
- 2. Yard Waste: Not to exceed (1) one regular truck load, loose items must be bundled 2' x 2', or bagged.
- 3. Moving Boxes: Must be broken down and bundled.
- 4. Miscellaneous: Not to exceed (1) one regular truck load, loose items must be bundled 2' x 2', or bagged.

Items not allowed:

- 1. Tires
- 2. Batteries
- 3. Animal carcasses
- 4. Paints and solvents
- 5. Concrete, rocks, dirt, and sod

This service is provided by MCT Waste and is conducted by one employee. Residents must adhere to these restrictions to allow MCT Waste to comply with environmental guidelines and to ensure employee safety.

How Do I Recycle In La Entrada?

Santa Fe County Solid Waste and Recycling Division operates a Recycling Convenience Center in Rancho Viejo at the corner of Avenida del Sur and A Van Nu Po (look for dirt road). The station is open on Friday and Saturday from 8:30 to 4:30 and accepts:

- 1. corrugated cardboard
- 2. glass
- 3. mixed recyclables
 - a. mixed paper materials including paper, paperboard and books
 - b. mixed containers including ALL plastic (regardless of #, but no styrofoam) and metal bottles, tubs, clamshells, packaging, cans and foil items and milk cartons/ juice pouches.

Tumbleweed Pickup

Proscape, the Association's Landscape Maintenance Company for the Common Areas at La Entrada, has agreed to remove any tumbleweeds left along the street each Wednesday (our landscape service day). Set the tumbleweeds out on the side of your street following this schedule and Proscape will remove them for you free of charge.

- South of Rancho Viejo Blvd (and Rancho Viejo Blvd itself): before 9 a m Wednesdays
- North of Rancho Viejo Blvd: before 12pm noon Wednesdays

There is no announced end date for this service, so for now we'll boldly assume it will continue for four weeks. Let Michael Smith know if you have questions or concerns.

Report on Reclaimed Water Advisory Committee Meeting

As a result of the Homework Group held in the fall of 2015 to address issues with the Effluent Irrigation, it was determined that a separate committee would be formed. The committee is made up of two residents from each Rancho Viejo community. Tom O'Brien and Doyle Preheim are the representatives from the North community, Bill Trujillo and Chris Schtzman are from the South Community, and your representatives from La Entrada are Drew Scott and Sally Dillon. The Reclaimed Water Advisory Committee met on Mon Feb. 22 to discuss each groups' position on plans to move forward and what we wanted to see completed before the irrigation season begins.

All of the representatives agreed that the VFDs (Variable Speed Pumps) be installed first to see how that improves watering issues. All agreed that this is the first step, however Smart Meters might be needed later on. The VFDs are ordered and, hopefully, installation should happen before the irrigation season starts. The VFDs will be paid with HOA funds in La Entrada.

A couple of options were presented for proposed irrigation schedules. La Entrada went on line for the irrigation of common areas in August 2015 and with continued construction and future park development, La Entrada will need 2 days of effluent watering of new plants.

Contractual agreements and the formalized schedule are forthcoming. The Reclaimed Water Advisory Committee will meet again when the documents are ready to present to the group.

At the Open House on Feb. 18th, new residents in Rancho Viejo learned more about the Santa Fe County Sheriff's Office. Deputies Carolina Aguayo and Robert Girmendonk from SFSO Community Support Services discussed the benefits of continued partnering with the Sheriff's Office to keep our community safe.



They emphasized that residents should call about anything suspicious and mention a description, especially anything that is unique. Information about the license plate, and direction of travel from your location are very helpful. One of the most important things to remember is to **never** approach the person or vehicle – **observe and report**. When you call to report, please be sure to give the complete street name of the location.

This is a very simple process that requires submitting a form which provides detailed information regarding any changes or improvements to the exterior of your home. This form is available at the sales office or may be downloaded at

www.laentradaranchoviejo.org.

It has come to our attention that some homeowners are not in compliance at this time. PLEASE, if you have completed work and have not submitted proper documentation, now is the time to do so. Do not hesitate to contact your HOA Manager, Michael Smith, with any questions you may have.

The La Entrada Board, in conjunction with the DRC, is actively following up on all the properties within La Entrada to ensure each has requested and obtained the appropriate approvals for changes to their property. Each homeowner should maintain any and all approval letters as part of their supporting homeowner documents.

The Committee would like to thank all residents who submitted requests last year for changes to their property. The Committee received 19 requests: 16 were approved, 2 were disapproved and one is pending. Thank you!

Firewise Success Stories

Last year at the Firewise/USA Day, it was noted that very few young people were involved in this activity. As a result, Dr. Judy Reinhartz, Rancho Viejo North resident, offered to design a curriculum program that featured fire ecology, forest ecological systems and How To Be Firewise for the students at Amy Biehl Community School.

This project was implemented in Aviva Markowitz's fifth grade class and involved several lessons that addressed Firewise information and materials. Each of the HOA's in Rancho Viejo contributed \$300 to purchase books, materials and "tree cookies" for the students to use.

Dr. Reinhartz also submitted and received a \$500 grant to continue the project at the school. Rancho Viejo was one of seven grant recipients in New Mexico. This included funding to design a poster contest and display set ups that will be presented at our Rancho Viejo/Firewise/USA/ Community Day scheduled for May 7, 2016. The fifth graders also participated in the "science book buddies" program engaging younger students to learn more about forest ecology through reading.

As a result of this project, Rancho Viejo was selected to present a workshop at the National Firewise Conference scheduled in Las Vegas, Nevada, in June. Dr. Judy Reinhartz, curriculum designer, and Krys Nystrom, forestry expert, will present a summary of the curriculum at the conference and represent our community as active Firewise participants.

I-25 / NM 14 (Cerrillos Road) City of Santa Fe, NM DIVERGING DIAMOND INTERCHANGE



Santa Fe Diverging Diamond Interchange (DDI) PROJECT UPDATE



AS YOU KNOW, the Santa Fe DDI project located at the interchange of I-25 and NM 14 (Cerrillos Road) is currently in construction. You might have noticed some changes in traffic patterns and several overnight closures.

The New Mexico Department of Transportation, Federal

Highway Administration, City of Santa Fe, Santa Fe County and Santa Fe Metropolitan Planning Organization have launched a major upgrade to the interchange, which is more than 40 years old. Over the past 20 years, this busy travel corridor has experienced traffic backups, bottlenecks, deteriorating bridges and unsafe merging distances on the current ramps. After extensive study and analysis, a Diverging Diamond Interchange - the first such interchange in New Mexico - was chosen to upgrade the interchange by making it safer and helping traffic flow more smoothly and safely for years to come.

The construction started in June 2015 and here is an update on our **progress**:

- The project is 50% complete.
- The outside portion of the new northbound I-25 bridge has been completed.
- The outside portion of the new southbound I-25 bridge has been completed.
- The pedestrian tunnels are partially constructed and can be noticed.
- A tremendous amount of dirt work has occurred and the final configuration can be identified.
- Changes to both the northbound and southbound I-25 on and off ramps are currently being constructed.
- Major sign structures are being replaced.
- A temporary traffic signal has been installed to ease the congestion of commuters traveling on NM 14 through construction.

Upcoming improvements you will see over the next few months include:

- Placement of the bottom layer of asphalt for all portions of the final configuration.
- Main line detours on both northbound and southbound I-25.
- Installation of storm drainage improvements.

Starting Monday, March 21, 2016, the I-25 northbound traffic has been shifted to a new detour alignment at the I-25/NM 14 Interchange. All truck traffic will be directed to travel on the right lane. There will be 11-foot lane width restriction and the speed limit will be reduced to 45 mph on I-25. Traffic can expect delays through the construction zone. Traffic will remain in this configuration until June of 2016.


