# Proposed Pilot/Flying J Travel Center and Truck Terminal

Genoveva Chavez Community Center Meeting
Tuesday, May 9, 2017 at 6:00 PM

The room at the Community Center was filled with approximately 50 interested Rancho Viejo residents for the meeting. James Siebert, land planning consultant for the Exit 278 LLC subsidiary of Rancho Viejo Limited Partnership (RVLP), presented information about the site of the potential development of the Pilot/Flying J Travel Center Truck Terminal. Site plans were shown, however they did not include the newly constructed Divergent Diamond Interchange at State Road 14 and Interstate 25.


Mr. Siebert explained the approval process, which includes a hearing with a hearing officer who will make a recommendation to the Santa Fe County Commission. Both meetings are public meetings and the public is welcome to attend and provide comments. The first hearing will be held in approximately two months with the County Commissioners' meeting occurring two months later.


The next portion of the presentation was by Ross Shaver, the project manager for Pilot/Flying J, who gave a detailed description of the proposed Truck Center site. It will be located directly across from the Rancho Viejo Blvd and Rt. 14 intersection on a 26-acre section of the vacant land, which is owned by Exit 278, LLC a subsidiary of Rancho Viejo Limited Partnership. There is a contract in place, but several studies, including traffic, need to be completed as part of the approval process.

Following the Pilot/Flying J presentation, there was an opportunity for questions. There were many concerns addressed by residents including lighting that meets Santa Fe standards, width of the Rt. 14 lanes, amount of traffic, limited exits from Rancho Viejo and safety concerns with added vehicles at the Rt. 14 and Rancho Viejo intersection, air quality with 70 trucks idling, noise from the trucks, number of jobs the center will create, home values, fuel spills, social aspects/crime/increased police needed, increased taxes for county services such as police, and the fact that the Truck Center will be people's first impression of Santa Fe.


As this process continues, please be vigilant for notifications of meetings and hearings so that the residents participating in the process *can* be heard.

# Save SF Gateway - Prevent Pilot/Flying J Meeting

A grassroots meeting was held on Sun. May 28, 2017 in the Village Park in Rancho Viejo, for the purpose to organize residents in working to prevent the building of the proposed Pilot Flying J Truck Center on the west side of the Rancho Viejo Blvd and Rt. 14/Cerrillos Rd interchange. Approximately 28 people attended the meeting. Judy Perkins led the meeting along with a few other residents.

There was discussion of the various concerns residents had regarding the future presence of the proposed Pilot Flying J Truck Center. Among those concerns were traffic, noise, air quality, crime, safety, etc. One of the residents talked about effective strategies for protesting the proposed Truck Center. Some important strategies suggested were doing the research, becoming familiar with the Santa Fe County Sustainable Land Development Code https:// www.santafecountynm.gov/userfiles/SLDC/ClickableSLDCwithOrdinance.pdf as well as Santa Fe County Growth Management and Land Use website https://www.santafecountynm.gov/growth management and finally attending and speaking at the County meetings throughout the process.

Other ideas were also discussed, such as exploring the experiences of other communities with Pilot Flying J Truck Centers, obtaining support from local environmental groups and conducting an air quality study, which Pilot Flying J is not required to do in the approval process.

Judy passed out 2 sheets to those attending. One was to check off the major issues with the proposed Truck Center that were important to the resident so they meeting organizers had some data. The second sheet was for attendees to list contact information and what tasks they were willing to do to prevent the Pilot Flying J Truck Center. The organizers may ask for monetary donations to help with operations going forward.

# Fourth Annual FirewiseUSA Community Day another Success!

On Saturday, May 6<sup>th</sup>, a gorgeous day in Rancho Viejo to recognize Firewise USA Community Day, over 50 residents from the North, South and La Entrada communities and the La Cienega Fire Department gathered for coffee and donuts in the parking lot in front of the Village Market. Young and old were given bright blue t-shirts with the Firewise/Rancho Viejo logo on the front before they began the task of cleaning up the community.

Residents were provided trash bags and free gardening gloves and were assigned specific areas to work. Participants visited with neighbors while they took charge of removing trash and fire fuel debris throughout common areas and around the

perimeter of developed areas. Trash bags and cut tree limbs were collected by Franco's, Heads Up and Proscape landscape companies that support our Firewise efforts and help us to comply with the Forestry Department recommendations.

Following the clean up, participants enjoyed a pizza luncheon in the Rancho Viejo Park. Afterwards, Annie McGovern from the South introduced the speakers. The plaque is rotated to each of the three communities on an annual basis.

# **Developer's Corner**

Estancia Homes is in the final stages of developing 58 new lots in La Entrada. These lots with new larger floor plans will be available later this summer.

In this phase of La Entrada, another park will be added to the developed open space component of the subdivision. The new park will be connected via the Spine Park to our open space system and offer playground equipment and sitting areas.

Some of you may have noticed some trench digging going on, all a part of the landscaping project that includes an irrigation line that will extend reclaimed water to the new section of development. This line runs behind the houses on Via Punto Nuevo and crosses Rancho Viejo Blvd west of Via Punto Nuevo.

To minimize dust from the lots a tackifier is sprayed onto the lots that helps keep the dust from blowing from the site. This product is quite sensitive, and the less amount of disturbance to it, the better. Please refrain from walking or driving on the new lots as this will help the product perform optimally.

The turnarounds at the end of Via Punto Nuevo and Camino Cerro Escondido have been installed and enable fire trucks to turn around. They are temporary and will be removed and the roads extended as development continues to the west.

We appreciate everyone's patience and understanding as this project wraps up. Thank you, Cass



## LA ENTRADA COMMITEE REPORTS




HOA Board Meeting

After the meeting was called to order, Michael Smith, HOA manager from HOAMCO, gave an overview of the Amendments to the By-Laws and Amendments to the Charter, which are available on the La Entrada website. These changes align better with the size of our community and give one vote per home in cases where resident voting is necessary. Michael also discussed the status of the Ranchland Utilities contract with the La Entrada HOA for Variable Speed Pumps used for the distribution of grey water for the irrigation of common areas in the community. By paying for the pumps, the community will have free effluent water for irrigation in the common areas for several years to come.

After the draft minutes were approved, Michael went over the financials. We have sufficient money in the operating account to cover monthly operating expenses and over \$155,000 in reserves for major repairs in La Entrada, such as roads, etc. There was a full audit of the financials for La Entrada and that will be posted on the web site. The Reserve Study is in process and that will also be posted and conveyed to residents. The board approved the financial report. Cass asked for committee reports. Sally Dillon reported on the Communication Committee's activity. Sally stated that the newsletter would only contain factual reports about the proposed Pilot Flying J Truck Center. Sally reported on the Firewise and Amy Biehl School 5K Race events that were successful. She briefly mentioned upcoming committee activities. Cass reported on the DRC (Design Review Committee).

In the Open Forum portion of the meeting, there was further discussion about the traffic on Rancho Viejo Blvd. Cass reported that he has met with the county several times and a traffic study is in process, as well as increased Sheriff's presence. While other suggestions were made, Cass stated that the county process is slow to move forward. A resident questioned what changes were being made to the CCRs. Cass stated that the changes were approved by the board a year to a year and a half ago, and that the finalized documents would be posted on the web site. Several residents wanted to discuss the proposed Pilot FlyingJ Truck Center. Cass said that the HOA board meetings were not the forum for these discussions, as it is a separate entity. Michael stated that the he HOA is not able to govern anything outside of its own community. The HOA remains neutral in its discussions regarding the Truck Center. La Entrada residents were encouraged to be involved in discussions at the public meetings for the proposed Truck Center. A resident brought up questions about parking and barking dogs near his home. Another resident brought up a concern about a dead tree and other landscape issues.

# Citizens' Police Academy

After recently completing the Citizens' Police Academy, I'd like to take this opportunity to encourage you to also enroll in this worthwhile educational program. The Citizens' Police Academy will start up again in September and will run for 12 consecutive weeks in two hour sessions. The instructors are from the Santa Fe Police Department, the New Mexico State Police and the Santa Fe County Sheriff's Department.

As a fairly new resident in La Entrada, I wanted to be aware of any possible criminal activities in the area and what I could do to protect myself and my neighbors. I joined the Neighborhood Watch and from its members learned about the Citizens' Police Academy and what I would learn from the experience.

Useful knowledge gleaned from the topics and discussions covered in the class far exceeded my expectations. Weekly sessions focused on:

- a history of the departments,
- criminal situational problem solving,
- traffic investigations,
- domestic violence.
- crime scene investigations,
- explosive ordinance and bomb technology,
- prison and street gangs,
- police response to resistance,
- police survival techniques,
- decisional shooting using simulated videos, and
- police driving on the state's law enforcement training track.

An additional learning opportunity was the "Ride Along" with a Santa Fe police officer during one of his shifts. The ridealong enabled me to see first-hand the problems an officer has to deal with on a daily basis. Although nothing major occurred while I accompanied the officer on his shift, I had an opportunity while in the police car to appreciate its capabilities, such as instant radio communications, the use of computer databases while driving in the vehicle, and the driving tactics used by the officer when needed to quickly arrive at potential emergency locations. I also had time to talk to the officer and hear his thoughts on the importance of community awareness and support.

The purpose of the Citizens' Police Academy is to develop a positive relationship between Santa Fe law enforcement and the community. My experience helped me become better informed of the services law enforcement provides us and the problems they encounter on a daily basis. From this course I better appreciated the role I and every Santa Fe citizen can play in making our law enforcement more effective. My eyes were opened to the criminal activity in our county, the warning signs of potential problems, and what I could and should do to timely alert the police so that potential criminal activity or escalation of criminal activity is abated.

I strongly encourage my fellow La Entrada residents to get on the band wagon and enroll in this worthwhile course. Let's work together with the police to make our community a safe and happy place to live. ## Understanding through Education

#### Residents Offered Inside Look at Santa Fe Police

SANTA FE, N.M. – If you have ever wanted to go behind police lines, see what it is like to really walk in an officer's shoes, learn how investigations are processed or simply train with Santa Fe's finest, now is your chance! The Santa Fe Police Department is offering residents the opportunity to sign up for its annual Citizens Academy.

The hands on Citizens academy runs for 12 consecutive weeks in two hour sessions, and also includes instructors from New Mexico State Police and the Santa Fe County Sheriff's Department.

#### Topics include:

- · Prison & Street Gangs
- Use of Force
- · Decisional Shooting
- SWAT K9 Training
- Police Driving
- · Crime Scene Investigation
- Department History

During the Use of Force and Decisional Shooting sections, applicants will have the opportunity to go through the department's virtual shooting simulator which sets up a scenario and provides participants with the opportunity feel what it is like to make split second decisions. It also runs them through proper training and procedures followed. Ever wanted to feel what it's like to be involved in a high speed chase? In Police Driving participants have the opportunity to hop in a police car, learn firsthand about the driving techniques and training officers must learn and then even accompany an officer through an actual driving obstacle course.

Finger printing and even forensic investigation techniques are covered in the Crime Scene Investigation section, and a trained K9 officer and police dog will demonstrate their abilities.

Residents will also be taken on a ride along be given an inside view of Santa Fe streets and the everyday working relationship officers have with our community.

The overall purpose of the Citizen's Academy is to develop a relationship between law enforcement and the community through education and create a nucleus of responsible, well-versed citizens who can inform the public and police department of criminal activity while offering any comments and ideas for solutions to problems facing Santa Fe and SFPD.

Applications are now available for the next academy beginning in February 23, 2017. Sessions are held Thursdays at 6 p.m. and will be held at the main police station located at 2515 Camino Entrada.

A background check will be completed, and applicants will need to sign various waivers. There is a \$45 application fee. Meals will be provided and graduates will receive a certificate and T-shirt. 


# Audra's Corner
