#### Holiday Activities for Our Local Fire Station and the Youth Shelter

Just because La Entrada did not have a community Holiday Party, that didn't



mean the Communication Committee didn't spread some holiday cheer. Cookies from Chocolate Maven were happily received from us at our local fire station. Coordinating with the Rancho Viejo Ladies Group we dropped off two carloads of wonderful items.

We returned another time with 3 laundry baskets of pre-bagged wrapped candy and

cookies. The staff at the Youth Shelter Street Outreach program drive around Santa Fe looking for potential clients living on the street who could benefit from their program. These goodie bags serve as a great icebreaker in connecting to youth in need. We did find out that cereal was something they also needed, so during that visit, the Communication Committee also provided 96 individual single serving boxes of cereal. The Youth Shelter had moved from a home on St. Francis to an office park on Pacheco, just north of the Coe Center.

During that second visit, we were joined by a long-time La Entrada resident, who back in 2010, served as the Communication Committee chair and was instrumental in developing our partnership with the Youth Shelter Street Outreach program by first bringing them turkeys for holiday meals. As we toured the building and the space used by the STAR Program, another need became apparent. The Star Program is



focused on rapid rehousing of unaccompanied youth from ages 18-24 and their dependents are offered up to 24 months of rental assistance and case management with the goal of maintaining permanent housing at discharge. In the Star portion of the building, there were stacks of dishes and kitchenware on the floor. They needed some shelving unit to store these items.

The former committee chair purchased one shelving unit and the Communication Committee recently and unanimously voted to support the purchase of a shelving unit even though it was purchased in December, when we were not meeting. These shelving units provided them to start the new year with places to store all the dishes and kitchen ware.

There are a variety of individuals right here in La Entrada, who provide support to the Youth Shelter Street Outreach Program on a regular basis and as a

Communication Committee, we are proud to have partnered with them for the last eleven years and look forward to continuing our partnership in the future.

## **Firewise, the New Normal**

In early February, all residents received a PDF created from a PowerPoint presentation that focused on Firewise. The date for the National Wildfire Community Preparedness Day is Sat May 7, 2022. We will have event but we are not sure yet whether it will be all of Rancho Viejo or just La Entrada. We should know very soon and we will let you know. In the meantime, mark your calendars for May 7th.

The focus is two-fold – one, removing fuels from urban interfaces beyond and near the wall and open spaces, common areas, open lots and two, working on your yard, clear the **5-foot Hazard Ignition Zone** around your home by removing fuels and reimaging your landscape plan.

The second focus is important because we now know that wildfires are no longer just in the forest. The Boulder County, Colorado grassland fire is of particular concern because we have exceptional drought and we have the fuels. While we would have to have the 100+mph winds, this fire is certainly a wake-up call to what we need to do differently.

In previous years, Firewise USA, in their publications stated that residents should limit what vegetation that is in the 5foot Hazard ignition Zone around their homes. This year the publications state eliminating vegetation in the 5-foot Hazard Ignition Zone around their homes. We are not asking you to rip everything out of your yard, but we are asking you to really look at your landscaping and ask yourself "do I have too many fuels in my yard that put my property and my neighbor's property at wildfire risk?" If the answer is yes, please seriously think about removing those excess fuels to make La Entrada as safe as we can.

Last summer, the Rancho Viejo South community had residents who had their homeowner's insurance cancelled because of their "close proximity to the National Forest." Their Firewise documented yard work may have helped to reinstate that insurance. Your insurance may be positively impacted by your documented wildfire mitigations and is certainly something you may choose to check on with your insurance provider.

Coming soon, you will receive more specific information regarding the event. You will also receive a Volunteer Hourly Worksheet and some other Firewise publications. You can keep track of the hours spent in your yard working on eliminating fuels and reducing wildfire risks. We will request those forms for documentation of our community work towards recertification as a Firewise community. You can always pick up tumbleweeds, etc. as it will always help with wildfire mitigation. You can make copies of the completed form for yourself, just in case you need it.

Finally, we are purchasing a Firewise Community sign that will be installed near the park at Via Punto Nuevo and Rancho Viejo Blvd.

#### Large Item Pickup Service Has Been Suspended





**Question:** I am thinking of repainting of the exterior my house. Is there anything that I need to know before I start painting?

**Answer:** It is wise of you to ask before going out and buying several gallons of paint and slapping it on your house!

The La Entrada Homeowner Handbook (a copy of which can be found on the La Entrada website) contains several provisions pertaining to repainting and possible exterior color choices of your house, all of which can be found on Pages 11 and 12 thereof.

In summary, if you are repainting your house using the same color scheme as what currently exists for your house, approval by the La Entrada Design Review Committee ("DRC") is not required. But if if you wish to change your existing house paint color, including any changes to the color of your door, you must first seek approval from the DRC for your proposed changes by submitting your proposal to the DRC prior to commencing any painting. Note that there is an already approved palette of paint colors for the stucco, trim, and doors of various series and models of houses within the neighborhood that you can choose from, and you can contact Serenity Lucero at HOAMCO (<u>SLucero@hoamco.com</u> for more information on the approved colors.

Additionally, please be aware that if you are constructing any new buildings or structures on your property, you must submit plans, specifications, and samples of the exterior color scheme for such building or structure to the DRC prior to commencing any construction.

**Question:** Winter was not kind to my plants and now my yard could really use a refresh. After visiting a few nurseries in town, I have lots of ideas for my yard, but can I just buy anything and plant it wherever I want?

**Answer:** Landscaping is a great way to express one's personal preferences on their property, but—as a consequence of living in La Entrada—there are a few limits on what you can plant and showcase.

Before buying any new plants, you should familiarize yourself with the provisions of Article K on Page 15 of the La Entrada Homeowner Handbook (a copy of which can be found on the La Entrada website) and, in particular, the Approved Plant List found in Appendix 1 thereto.

Of particular note, please be aware of the following provisions: First, any landscape installation(s), modifications, improvements, or additions are to be submitted to the Design Review Committee ("DRC") prior to installation; and Second, DRC approval is not required, however, for replacement of dead plant material so long as the replacement plan is the same type of plant and is planted in the same location.

In regards to the first noted provision, though, the La Entrada HOA Board recently agreed that the La Entrada Community Manager can provide *pro forma* approval of landscaping DRC requests that only contain plants on the approved plant list (with formal approval from the DRC to follow at a later date), thereby allowing residents to take advantage of impulse buys, plant sales, or the like of plants that are (i) on the approved plant list; and (ii) to be planted in the locations allowed as stated in the approved plant list.

As a general rule, just about any plant that is for sale at a professional nursery in the Santa Fe area and that is stated to be able to survive the region's climate is likely on the approved plant list, but you should still cross-check any potential plant purchase against the approved plant list prior to purchasing it. And even despite the *pro forma* approval process noted in the previous paragraph, you should still submit a DRC landscaping request.
